At our first Village Senior meeting the Riverwoods/Lincolnshire Fire Department spoke about the need for Knox Boxes and the Lifeline Program. Knox Boxes are boxes placed outside your home. These boxes are only accessible by the fire department. Each box contains the key to your home. The fire department explained that currently there is a no break-in policy in place, so that if you call 911 for help and are unable to open the door, the fire department is very reluctant to break the door down to get to you. They are highly recommending that all of our residents get Knox Boxes. The current cost of a box is about \$150.00. Please contact Nancy at the Village to let her know if you are interested. We would like to place a large order at one time to see if we can get a reduced price for our residents.

My wife, Sherry, and I also signed up for the Lifeline Program. It is a wonderful free program provided by our fire department. Two firemen came to our home and took our complete medical history. They asked us which of our three local hospitals we would prefer and got our primary physician's name and phone number. They also made a list of our current medications and any medications to which we were allergic. After gathering the information it was placed in a packet in our home and a sticker was placed on the window near our door. This will notify a paramedic that the information is available inside. This program could truly be a life saver. I strongly urge every family in Riverwoods to take advantage of this wonderful free service. Please contact the non-emergency number of the Riverwoods/Lincolnshire Fire Department (847) 634-2512 to make an appointment.

As I am sure you are all aware, the Shoppes of Riverwoods are now opening. Currently Panera Bread and Baja Fresh are open. Watch for new shops opening in the near future.

Finally, on Thursday, October 16, 2003, I attended the senior potluck luncheon at the Village Hall. I found it to be a delightful experience both the company and the food was good. I urge our senior residents to attend the monthly programs being offered on the third Thursday of each month at the Village Hall. # Update of Current Village Board Topics

August 5, August 19, September 5

## **PROPOSAL ESTABLISHING OF WHIGHAM-BURR OAK SSA #20**

The Village Board adopted an Ordinance Proposing the Establishment in the Village of Riverwoods of Whigham-Burr Oak Special Use Service Area #20 for Water System Improvements benefiting Certain properties on portions of Whigham Road, Burr Oak, Hoffman Lane, Portwine Road, and Riverwoods Road; and providing for a public hearing and other procedures.

## **AMENDING CODE RE SOLICITORS**

Based on the results of a Supreme Court case, religious and charitable solicitation is permitted without a fee. According to Trustee Haber, this is a First Amendment issue. Residents can post "No Solicitators" signs in response. Signs are available at the Village Hall.

## **ALLOW MONTESSORI SCHOOL TO BE USED AT ARTS AND RIVERWOODS**

The Village Board voted to allow the Riverwoods Montessori School to be used as one of the show homes during Arts & Riverwoods. At that time, the Arts & Riverwoods committee was having difficulty finding homes for the show.

## **APPROVE DONATION OF \$5000 TO DBR CHAMBER OF COMMERCE**

The Village Board approved a \$5000 donation to the DBR Chamber of Commerce to promote area businesses.

## **APPROVE S.B. FRIEDMAN & CO. AS DEVELOPMENT CONSULTANT**

The Village Board approved hiring S.B. Friedman as a consultant to the Village of Riverwoods with the development of 37 acres.

## **REDUCE LETTER OF CREDIT FOR SHOPPES OF RIVERWOODS TO \$689,942**

The Village Board granted Gewalt Hamilton's request for a reduction in the letter of credit to \$689,942 for the Shoppes of Riverwoods.

## **MANHOLE REHABILITATION PROJECT**

The Village Board authorized spending up to \$40,000 for the rehabilitation of manholes within Village in conjunction with Lake County on 50/50 basis.

## **VILLAGE WEB SITE**

The Village Board accepted the Borchew Design Group's proposal to host and update the Village web site for \$400 per month. The design group spent 75 hours setting up the website at no cost to the Village.

## **TREE REMOVAL ORDINANCE PASSED**

The Village Board agreed to pass an ordinance giving the Village permission to remove trees that create an imminent danger or obstruct public or private ways.

## **MFT ROADWAY PROJECT UNDERWAY**

Peter Baker and Son's bid of \$330,214.51 was accepted for 2003 MFT Roadway Maintenance Project.

## **CLOSED SESSION MINUTES**

### **NOW AVAILABLE**

The Village Board authorized the Village Clerk to make Closed Session minutes, from January 2003 through July 2003, available for public inspection.

# Fire News – Beware of fraud

The LRFD, Lincolnshire Riverwoods Fire Department, would like to remind residents of the ever present efforts of some groups to solicit funds in the name of fire service organizations when, in reality, an extremely small percentage of funds collected ever make it to the assumed beneficiary. Although there are numerous groups that engage in this practice, we have recently discovered a phone solicitation followed by a mailed “pledge card” from the Association for Disabled Firefighters (ADF). According to the Better Business Bureau, since 2001 the ADF has been charged with deceptive practices by the Attorney General offices in Arizona, Oregon, and North Dakota. Among the specific charges were “falsely representing that contributions would go to a charitable purpose, when in fact only 0.7% of the total collected funds went for charitable purposes”.

The LRFD does not solicit money from its residents, either by telephone or mailers. In the past, off-duty firefighters have collected funds for charitable organizations such as the Muscular Dystrophy Association and the New York Firefighters Widows and Children’s Fund but these solicitations have always been in person (fill the boot drives) and in uniform so as to be easily recognized. The LRFD cannot always confirm the validity of groups soliciting funds related to the fire service. It is recommended that for information on such groups residents contact the Better Business Bureau at [www.bbb.org](http://www.bbb.org) or 703-276-0100.

## **The Better Business Bureau offers the following advice for giving to charities:**

Most charities are honest and ethical, but questionable solicitors are counting on the fact you won’t check out the charity before giving. Here is some basic wise giving advice:

1. Watch out for similar names. Some charity names sound the same. Be sure to look at the name carefully because it may not be the one you have in mind.
2. Do not be pressured into an immediate gift. Charities should welcome your gift whenever you want to send it.
3. Question vague appeals. They should clearly identify the charity’s programs.
4. Do not give out personal information to phone solicitors. Don’t give out credit card numbers, checking account numbers or any other personal information to unknown telephone solicitors.
5. Do not give cash. Write a check out to the charity’s full official name, not to an individual or 3rd party that

may be collecting the donation.

6. Don’t hesitate to ask the charity for written information on its programs and finances. This can be particularly helpful in responding to phone appeals from charities that interest you.

7. Report bad practices. Contact your Better Business Bureau and your state’s Attorney General Office about solicitation problems.

## **Furthermore, the Illinois Attorney General’s Office offers the following:**

1. Ask the caller the name, address and phone number of the company or charity they are calling on behalf of.
2. Ask whether the solicitor is a professional fund raiser, and if so, how much of the donation actually goes to the charity.

# Tree Removal Permits Required in the Village of Riverwoods

The Village Board, in response to concerns regarding tree preservation and woodland management in the Village, has recently modified and updated the Village's Tree Preservation Ordinance (no. 03-6-7) for the preservation of Protected Trees.

There are two types of tree-related permits that the Village issues under the Tree Preservation Ordinance: Tree Removal permits and Forestry permits.

**Tree Removal** permits are issued when an applicant wants to remove trees that are dead, diseased, dying, or when trees need to be removed for construction purposes.

Tree Removal applications are reviewed by the Village Forester. Based on the review, the Forester may require trees to be planted to replace protected trees being removed. Tree replacements are calculated based on the number of inches of trunk diameter removed, i.e. when a protected tree with a trunk diameter of 20" is removed, 20" of replacements are required. In some cases, more replacements are required than there is space for on the applicant's property. When this occurs, the Forester determines the number of trees which can be replanted at the site and the remaining number of inches are applied to a 'Fee in Lieu of' calculation (\$20/ diameter inch). The 'Fee in Lieu of' payment is then placed into a Village fund for the Tree Planting program.

The fee for a Tree Removal permit is \$75.00. However, there is no permit fee for dead, diseased or dying trees.

**Forestry permits** are issued to residents participating in the Tree Planting program (Village's Ordinance Providing for the Preservation of Protected Trees (no. 03-6-7, sec.5-5-9). This program uses matching funds generated from the 'Fee in Lieu of' payments to aid residents with woodland restoration projects including tree planting and/or the removal of invasive, noxious or non-indigenous trees, plants and weeds, such as buckthorn and garlic mustard, that interfere with the health, conservation and expansion of the oak-hickory hardwood forest and other Protected Trees that constitute the indigenous and desirable woodland habitat for the Village.

Applications for Forestry permits follow a similar process as Tree Removal permits. But because residents apply for matching funds as part of the program, they must include a copy of a signed work contract and a copy the contractor's valid State of Illinois Applicator's License, as specified in the Village's Guidelines for the Removal and Control of Buckthorn and Garlic Mustard, if herbicides will be used. When the work is completed, the

Forester performs a site inspection to determine if the work was done in accordance with the application. When all work is completed and approved, the Village issues a reimbursement check to the resident. The program is a 50/50 cost-share, with a maximum of a \$1,000 reimbursement. The fee for a Tree Removal permit is \$75.00.

The Village policy requires all tree and brush removal work to be documented, regardless of whether or not the trees being removed are 'protected' trees under the Village's Tree Ordinance. This means that residents are asked to fill out an application so the Village has a record of the work to be performed. This is intended to save time for the police department, as they are the ones who most often have to respond when residents call the Village to report tree removal work in progress. Having a properly completed copy of a permit application on file will assist them in identifying tree removals taking place without a tree removal permit. There is no permit fee associated with the removal of brush or 'unprotected' trees.

# SWALCO Household Chemical Waste Collections Confirmed for November 2003

The Solid Waste Agency of Lake County, IL (SWALCO) is continuing this year's Household Chemical Waste (HCW) collection program to help residents dispose of their chemical wastes safely and conveniently. Latex paint is no longer accepted at HCW collections. These free events are open to Illinois residents ONLY from 8:00am to 2:30pm:

Highland Park - Wolter's Field  
1080 W. Park Avenue

A variety of common household materials can be brought to a HCW collection day, including:

<i>oil-based paints</i>	<i>used motor oil</i>
<i>mercury</i>	<i>solvents</i>
<i>paint remover</i>	<i>antifreeze</i>
<i>aerosol products</i>	<i>metal polishes</i>
<i>insecticides</i>	<i>old gasoline</i>
<i>hobby chemicals</i>	<i>pool chemicals</i>
<i>weed killer</i>	<i>fluorescent bulbs</i>
<i>household cleaners</i>	<i>household batteries</i>

Business, institutional and commercial wastes, explosives (such as fireworks and ammunition), propane tanks, smoke detectors and fire extinguishers, agricultural chemicals, medical wastes, and Latex paint will not be accepted at any of the agency's HCW events. Tires and lead acid batteries (auto and boat batteries) are also not accepted at these collections. These items can be recycled at any retail outlet that sells them.

To help residents dispose of Latex paint, SWALCO provides bags of crushed corn cobs at various locations around Lake County. Crushed corn cobs are very absorbent, and can dry out a can of paint in as little as 30 minutes. After equal parts of paint and crushed corn cobs are mixed together and allowed to dry, the cans of paint can be disposed of with the rest of the resident's trash.

SWALCO provides this free service to residents so that harmful chemicals do not end up contaminating our land, water and air resources. Residents can call the Solid Waste Agency of Lake County at 847-336-9340 or check the agency's website ([www.swalco.org](http://www.swalco.org)) for further information about the HCW collection events and the availability of crushed corn cobs for Latex paint disposal.

## Water News

### Connections

Please be sure to contact Swanson Water Treatment to have a water meter installed once the plumber has finished his connections and you are ready to have the water turned on. Their number is (847) 680-1113. In the event of a water emergency please call Lake County at (847) 680-1600.

### High Water Bills

There have been several calls from residents that their water bills have been quite high. Please keep in mind that summertime is the high time of the year with lawn and garden sprinkling, kids home from school, and in some cases, pools being filled...etc. Also, Meadowlake residents should realize that because you are on city water as opposed to the community well, bills will be twice as high. The rate for the city water is \$5.00 per thousand gallons, not \$2.50 per thousand gallons for the community well water. If you think that your read is way higher then it should be, there is always the possibility that you may have a water leak somewhere. If you have an underground sprinkling system, you should be aware of where the sprinkler heads are. Sometimes one can get knocked to the side by a lawn mower and water will leak out at an astronomical rate. Your sprinkler company can check for leaks in your system. Also be aware of a toilet running. A huge amount of water can leak down the back of the toilet without anyone being aware. Both of those issues should be addressed as soon as possible. A leak check can be scheduled if you think there is water that is unaccounted.

### Water Readings

Water reads are taken every three months and the payment is always due by the last working day of that month. If you don't receive a bill by at least the 10th day of any month that a read is scheduled for your residence, it would be a good idea to call the Village Hall to find out what the balance is. There is a 10% penalty assessed on any outstanding balance every month.

### Regarding Closings

In the event that you should decide to sell your home, please call the Village Hall so that we can obtain information about your closing date and where to send the final bill.

After the holidays the school will begin preparing their activities for National Montessori Week, beginning February 23, 2004.


