

PRESCRIBED BURN COST-SHARE PROGRAM

Thank you for your interest in the Village's Prescribed Burn Cost-Share Program. The program requirements are authorized by "An Ordinance Providing for Ecological Cost-Share Programs in the Village of Riverwoods" and are subject to such ordinance, as from time to time amended. Note: an Ecological Consultation and approval from the Village Ecologist is required prior to applying for the Prescribed Burn Program. **Please read all requirements carefully and complete the checklist before submitting your completed application.** The Prescribed Burn Program is a 50/50 cost share program. The Village's share limit is \$2,000. The applicant is not eligible to re-apply for 3 years. There is a \$150 non-refundable application fee. Note: prescribed burning requires trained workers. Therefore, the Village will not reimburse an applicant who performs the work themselves rather than hiring a certified contractor.


The intent of the Prescribed Burn Program is to provide an incentive for residents with relatively healthy woodlands and/or prairies to maintain the health of these areas using fire which was very common prior to European settlement in the 1830s. Prescribed burn management is safe when conducted by trained professionals and helps improve the health of woodlands or prairies by removing thatch, replenishing soil nutrients, and allows desirable native plants to thrive.

To be eligible to participate in the program, the applicant must certify that they will comply with all requirements set forth in the packet. The property owner is responsible for obtaining all burn permits, property locations and staking their property lines prior to burning and notifying adjacent residents, etc.

After the Prescribed Burn Permit Application is approved by the Village Ecologist, the applicant will receive a permit from the Village to proceed with the work. Once the work is completed, notify the Village within one month and the Village Ecologist will conduct a site visit to verify the burn has been completed and Performance Standard met. The reimbursement request is then forwarded to the Village Board for approval. Reimbursement can be expected in 1 to 3 months following the approval of work.

Checklist for Prescribed Burn Program:

1. Conduct the required Ecological Consultation (to generally locate proposed burn area) with the Village Ecologist.
2. Receive cost share report with map and work specifications (completed by Village Ecologist) including Prescribed Burn Program information packet & application. The application form is attached but can also be obtained from Village Hall or by downloading from the Village Website.
3. Select a certified Contractor then submit completed application form & Contractor proposal/contract to Village Hall. The Village Ecologist will review the Contractor proposal/contract to make sure it conforms to the cost share report/map requirements and contact the applicant, if necessary, for clarification.
4. Receive permit from Village then hire certified qualified Contractor to perform the prescribed burn per the provided cost share report map, Contractor Specifications, and Performance Standards.
5. Following completion of work, submit a copy of the paid contractor invoice to Village Hall and request a final inspection by the Village Ecologist. The Village Ecologist will inspect the work to make sure it conforms to the cost share report/map, permit, and Performance Standards. Village Staff will review the Contractor invoice and contact the applicant, if necessary, for clarification and approve the payment of reimbursement from the Village. The Village Board will then approve the reimbursement payment to the applicant within 1 to 3 months.

CONTRACTOR SPECIFICATIONS FOR PRESCRIBED BURNING

PART 1.GENERAL

1.1 DESCRIPTION

- A. THIS SECTION INCLUDES PRESCRIBED BURNING.

1.2 QUALITY ASSURANCE

- A. QUALIFICATIONS OF WORKMEN: PROVIDE AT LEAST ONE PERSON WHO SHALL BE PRESENT AT ALL TIMES DURING EXECUTION OF THIS PORTION OF THE WORK, WHO SHALL BE THOROUGHLY FAMILIAR WITH THIS TYPE OF WORK AND THE TYPE OF EQUIPMENT BEING USED. SAID PERSON SHALL HAVE BURN TRAINING. SAID PERSON SHALL ALSO DIRECT ALL WORK PERFORMED UNDER THIS SECTION.
- B. THE VILLAGE MUST HAVE APPROVED THE PROPOSED WORK.
- C. STANDARDS: ALL MATERIALS USED DURING THIS PORTION OF THE WORK SHALL MEET OR EXCEED APPLICABLE FEDERAL, STATE, COUNTY AND LOCAL LAWS AND REGULATIONS.

1.3 SUBMITTALS

- A. ANY REQUIRED BURN PERMITS AND CONTACTS WITH VILLAGE AND FIRE DEPARTMENTS.

PART 3.EXECUTION

3.1 METHOD

- A. PRESCRIBED BURNING SHALL BE CONDUCTED IN THE FALL (NOVEMBER-DECEMBER) OR SPRING (MARCH-APRIL). BURNING SHALL BE CONDUCTED BY A CONTRACTOR EXPERIENCED AND TRAINED IN BURN PLANNING AND PERMIT APPLICATION AS WELL AS PRESCRIBED BURN MANAGEMENT.
- B. PRIOR TO THE COMMENCEMENT OF PRESCRIBED BURNING, THE CONTRACTOR SHALL COMPILER A BURN PLAN THAT OUTLINES A PLAN OF ACTION, IDENTIFIED CONTINGENCIES, AND LISTS THE NAMES AND PHONE NUMBERS OF EMERGENCY AGENCIES (FIRE DEPARTMENT, POLICE DEPARTMENT, ETC). PROPER NOTICE OF INTENT TO BURN SHALL BE GIVEN.
- C. THE OWNER SHALL APPLY FOR AND RECEIVE ALL REQUIRED PERMITS PRIOR TO THE COMMENCEMENT OF PRESCRIBED BURNING.

3.2 INSPECTION, ACCEPTANCE, AND PERFORMANCE STANDARDS

- A. WITHIN ONE MONTH FOLLOWING THE PRESCRIBED BURN, THE APPLICANT SHALL SCHEDULE WITH THE VILLAGE AN ACCEPTANCE INSPECTION.
- C. PERFORMANCE STANDARDS: **THE CONTRACTOR GUARANTEES THAT 70% OF THE GROUND COVER SHALL BE BURNED UNLESS OTHERWISE APPROVED BY THE VILLAGE ECOLOGIST.**
